Test Site Information

The testing will be in a fire hall with linoleum flooring. There are no steps in the building. There will be separate entry and exit doors to the testing area. Two restrooms are located in the ORT area and may NOT be used during testing. All dogs must be crated in your car until they are being tested, as there is no inside crating at the ORT facility. You are responsible for picking up after your dog. Please bring your own lunch as needed. Several sit down and fast food restaurants are within 1 mile of the facility.

ALL DOGS MUST BE ON LEASH AT ALL TIMES.

Entry Requirements

The handler of the dog must be a current member of the NACSW™. The Dog must be registered with the NACSW™. Score books are optional and are not required to participate in an ORT.

They are for personal record keeping. If you have lost a scorebook and would like a replacement, you can request a replacement book that will include all your prior NACSW results. Log in to your account at:

and choose the option to order a replacement score book there. The cost is \$20.

Entry Fee and Second Dog Policy

\$30.00 first odor per dog. \$30.00 subsequent odor for each dog.

Please fill out a separate registration form for each dog and odor to be tested.

Closing Date

Entries and payment must be received at the Secretary's address by June 18, 2017 at 5:00 pm. Overnight mail entries must have the signature request waived.

Refund Policy

Cancellations made on or before June 1, 2017 by 5:00pm will be refunded minus a \$10 administration fee per test. No refunds after the entry closing date. Cancellations may be made by e-mail to michelle@yourmannerlymutt.com. The secretary is not responsible for lost e-mails or calls that do not reach her. The secretary will send an e-mail back to the participant confirming the cancellation.

TEST INFORMATION - NOTICE TO EXHIBITORS

HANDLER BRIEFING: Detailed information about running times and briefings will be sent via email approximately a week before the ORT.

Exhibitors may bring their dog's SCOREBOOK with them to the test. Results are recorded in the SCOREBOOK. The SCOREBOOK is not necessary to take the ORT.

NO SPECTATORS ARE PERMITTED IN THE SEARCH AREA during the ORT except NACSW™ officials, adults accompanying a minor, CNW/intraining, or immediate family members/friends of the dog/handler team currently being tested.

ENTRIES:

- TELEPHONE, FAX, UNSIGNED ENTRIES, AND ENTRIES RECEIVED WITHOUT FEES cannot be accepted.
- RETURNED CHECKS do not constitute a valid entry fee. A charge of \$25.00 will be made for each returned check.
- ENTRIES MUST BE MADE ON THE ATTACHED ENTRY FORM.
- NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED, WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.
- OWNERS are responsible for errors in making out entry forms.
- EXPRESS MAIL entries must include signature permitting them to be left at the secretary's address without recipient's signature.

DOGS PRESENT will not be permitted to roam. Exhibitors are responsible for the behavior of their dogs. The owner of each dog is solely responsible for having it ready when it is to be judged. Be prepared to keep your dog in your car when not being tested or on leash at all times.
There is no inside crating at this test.

FEMALES IN SEASON – Contact your test host if this becomes a possibility

DOGS PARTICIPATING in ORT must be at least six months of age and must appear to be healthy on trial day and should be current on all vaccinations required by law.

Acknowledgement of entry acceptance/CONFIRMATION will be made when entries are processed for those handlers that provide an email address. If you require a confirmation via USPS, you must provide a self addressed stamped envelope with your entry.

BASIC DESCRIPTION OF TEST – to successfully pass an ORT a dog must identify the location of the target odor and the handler must correctly call an "alert" within a three minute time period. The Odor Recognition Test consists of a drill type exercise which requires 12 closed boxes set up in a pattern of one or two rows spaced a minimum of 48" apart. The ORT is conducted on leash. Complete information can be obtained on the NACSW™ website. *All exhibitors should obtain and review a copy of the **NACSW™ K9 NOSE WORK® RULE BOOK**.
